# **Ground Rules and Accessibility**

- Volume check?
- Use the space however you need to-stand, pace, etc.
- Take breaks as necessary
- Respect individuals' privacy: "What is said here stays here; what is learned here leaves here."
- Don't assume everyone present agrees with you or shares any of your experiences—assume a diversity of experiences and opinions.
- Approach disagreement or differences in experience with curiosity.

- Weingarten Rights
- Talking to your colleagues on the clock
- Academic Staff Policies and Procedures (ASPP–UW-specific)
- Grievances
